Terms and conditions

Equipment use:

The 'hirer' shall at all times use the equipment in a skillful, sober and proper manner and shall at his own expense service, clean and maintain the equipment. The 'hirer' accepts full responsibility for the security and safe use of the equipment until collection or return to **Event Hire Services**.

Cleaning of equipment:

Upon completion of the hire, the equipment must be properly cleaned or at least rinsed by the 'hirer'. It is agreed that the whole or any part of the cost incurred by the owner arising out of the 'hirer' failing to adhere to this clause will result in the owner charging the time to clean those products in question.

Freight:

The 'hirer' shall be responsible for all freight and other charges incurred by the owner in respect of the delivery and return of all the equipment hired. The owner will make all reasonable efforts to replace any equipment that is damaged due to reasonable wear and tear and not by the 'hirer's' negligence.

Loss or breakage of equipment:

The 'hirer' shall be responsible for any lost or stolen equipment for any reason whatsoever. The 'hirer' is responsible for any breakages and losses – which will be charged at replacement cost.

Damage to property or person:

The 'hirer' shall be responsible for any loss of or damage to property or person caused by the equipment for any reason whatsoever during the period of hire and the 'hirer' shall indemnify the owner in respect of all claims damages and expenses in relation thereof. This includes damage to property or person upon delivery.

Period of hire:

The period of hire shall commence from the commencement date shown on the quotation provided or from the time the equipment is delivered to the 'hirer'.

Whilst **Event Hire Services** will make every endeavour to supply equipment as described in the current catalogue and website, all items are offered subject to availability. Circumstances may lead to alternative products being offered or supplied, but they will conform to the same standards and every effort will be made to contact and inform the 'hirer' beforehand.

If equipment cannot be supplied on the agreed date because of circumstances beyond its reasonable control, **Event Hire Services** shall return all monies paid and not be liable to pay further compensation to the 'hirer'.
